#### BACKGROUND

DOSURPU in fulfilling its mandate to provide affordable housing solutions has undertaken the creation of a new Housing Development Incentive Programme (HDIP). HDIP is aimed at stimulating private development in the housing sector by encouraging private Land Developers to develop serviced lots to satisfy the current demand for affordable housing solutions.

DOSURPU now wishes to invite private Land Developers to submit Expressions of Interest demonstrating capabilities and capacities as follows:

- i. To make available serviced lots to the applicants on DOSURPU's Housing Application and Fulfillment System (HAFS) Database. The minimum size per lot to be provided is 5000 sq.ft and minimum services to be provided include water and wastewater, electricity, drainage and road access. The Land Developer is responsible for obtaining approvals from all statutory/regulatory authorities.
- ii. For residential parcels ascribed a selling price not exceeding \$500,000.00, a 25% subsidy shall be provided by the THA. The subsidy amount would be provided in respect of each successful participant of the HDIP provided that the successful participant is an applicant from DOSURPU's HAFS Database.
- iii. The THA will also provide State Lands (on terms and conditions to be agreed upon) to participants without lands, who wish to participate in the programme.

Interested participants MUST purchase the Programme Package for a non-refundable fee of Five Hundred Dollars (\$500.00). Payments are to be made with Managers Cheques payable to "Administrator, Division of Settlements, Urban Renewal and Public Utilities" to the Procurement Unit at DOSURPU's office located at D Colosseum Building 2, Corner Bypass and Milford Roads, Crown Point, Tobago, from, 2021 (excluding weekend and public holidays) from 8.15 am to 3.45 pm.
