# **1. BACKGROUND INFORMATION**

The Buccoo Integrated Facility was built and dedicated to the vibrancy of the village of Buccoo by being dual purposed, offering affordable commercial rental spaces in order to assist Buccoo's entrepreneurs, as well as being home to a variety of rental spaces for the hosting of events. The maintenance, both ongoing and preventive, as well as developmental projects, are at the forefront to continually develop the Buccoo Village.

# 2. PURPOSE OF THE INVITATION TO TENDER (ITT)

The Buccoo Integrated Facility provides services to varied groups of individuals inclusive of the general public. Plumbing issues that arise usually affect tenants, staff, clients and the general public. It is critical therefore that the facility be able to treat with these issues when they arise in the shortest possible timeframe to restore functionality to the facility. It is also important that the facility is afforded access to regular plumbing services as the facility is heavily even oriented. As such, the purpose of this ITT is to solicit responses from contractors registered with the Tobago House of Assembly to provide

- Monthly general maintenance of the plumbing, sewerage, fire suppression and irrigation systems;
- Monthly pump maintenance; and
- Supply and install one (1) fire pump.

# 3. ELIGIBILITY

Tenderers that are domicile in Tobago and pre-qualified in the category **"PLUMBING AND ELECTRICAL SUPPLIES & SERVICES - 15-PCO-078"** are invited to tender. If tenderers are not certain of their prequalification status, please contact the Procurement Control Office to ensure your eligibility to participate in this tender.

# 4. **DUE DILIGENCE**

Additionally, a bidder, and all parties constituting the bidder, shall meet the following criteria to be eligible to participate in public procurement:

- a) the bidder has the legal capacity to enter into a contract;
- b) the bidder is not:
  - a. insolvent;
  - b. in receivership;
  - c. bankrupt; or
  - d. being wound up, administered by a court or judicial officer
- c) the bidder's business activities have not been suspended;
- d) the bidder is not the subject of legal proceedings for any of the circumstances in (b);
- e) the bidder has fulfilled his or her obligations to pay taxes and national Insurance Contributions;
- f) the Directors and/or Principal Officers have not been convicted for any criminal offences.
- g) this tender is open to Tenderers domicile on the island of Tobago.
- h) the bidder must have the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, managerial capability, reliability, experience and personnel to perform the procurement contract; and
- i) the bidder must meet relevant industry standards.

## 5. SCOPE OF WORKS

## 6. FORMAT OF TENDERS

- (a) Tenders shall comprise a Single-Envelope System, this means a single envelope containing both the financial and technical/quality information for evaluation.
- (b) The original and the copies of the tender shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the Tenderer.

(c) Alterations or erasures on any tender shall be initialed by the bidder or, in the case of a company, partnership or firm, by a duly authorized officer or employee of such company, partnership or firm.

Acknowledgements must be signed by the person making the offer or in the case of a company, partnership or business firm, a duly authorized officer or employee of such organization.

# 8. TENDER SUBMISSION INSTRUCTIONS

#### g) ABILITY TO FINANCE THE PROJECT (EVALUATED)

Tenderers must demonstrate that they have the financial/other capacity to start and finish the project and are asked to provide financial/other evidence from:

- a recognized financial institution (Financial institution, financier) demonstrating the ability to finance the cost proposed in the tender. Letter must give a range, e.g. high five digits etc.
- Contractors that provide letters from businesses agreeing to finance the project must ensure the following:
  - i. Letters MUST be done on the business letterhead
  - ii. Letters must state the amount (in dollars) the business is affording the contractor
  - iii. Letters must be signed and stamped by a principal of the business
  - iv. The contractor's signature must also be on the agreement letter from the business
  - v. Copies of the Certificate of Incorporation and the Notice of Directors MUST be provided to support the legitimacy of the business.

- b. Supply and installation shall be **CLEARLY** identified.
- c. Monthly maintenance costs shall be CLEARLY identified
- d. Quotations must be signed and stamped.

<u>No additional information</u> is to be submitted other than that requested above. Any additional information not requested shall not be taken into account or may result in disqualification. All submissions must be neatly bound, numbered and company stamp MUST be affixed to each page. The Division reserves the right to reject tender documents that are poorly assembled or tabbed and not in keeping with the specific order.

# **10. TENDER SUBMISSION**

All tenders must be submitted in sealed envelopes, labelled in **BOLD** letters and addressed as follows:

Tenderers **MUST** submit one (1) original and four (4) copies of their bids. The envelope of the original bid **MUST** be labelled as **"ORIGINAL"** in **BOLD** font and the envelopes containing copies **MUST** be labelled **"COPY"**. Envelopes must be properly sealed with the bidder's returning address and contact number at the back of the envelope.

Tenderers **MUST** also affix their company's seal at the front of the Envelope, Moreover, the company's seal must be affixed to all pages of the bid submission and duly signed by the Tenderer.

## **11. TENDER OPENING**

Tenders shall be opened at the Procurement Control Office, Spring Garden Office Facility, Spring Garden Trace, Tobago on **Tuesday 28<sup>th</sup> March, 2023 at 2:15pm**. All tenderers are invited to be present for the opening.

# **12. EVALUATION OF TENDERS**

The OCS retains a separate right to waive irregularities in the tender submission if in the Division's discretion such irregularities are of a minor technical nature or relate to defects.

Where documents submitted by the tenderer are of a <u>statutory nature only</u>, and are materially incomplete or inaccurate, the OCS has the discretion to enter into an award with the successful tenderer, subject to the incomplete or inaccurate statutory document being remedied by the tenderer within seven (7) days.

Where the successful tenderer has a price that is in the opinion of the tender evaluation committee deemed to be abnormally low, the tenderer shall be required to provide additional information to substantiate their bid. This may include a detailed price breakdown structure, failing which, the tender shall be rejected by the Committee as an abnormally low submission.

## **14. LATE TENDERS**

Late tenders will not be accepted under any circumstances. The OCS reserves the right to reject any or all tenders, in whole or in part, to negotiate changes in the scope of services and waive any technicalities as deemed in its best interest.

## 15. NO CLAIM FOR COMPENSATION

Except as expressly and specifically permitted in this Tender document, no Bidder shall have any claim for any compensation of any kind whatsoever, as a result of participation in the ITT, and by submitting a tender each bidder shall be deemed to have agreed that it has no claim.

## **16. INDEMNITY**

Tenderers in submitting a tender, commits to indemnify the THA, its employees, agents and or servants, or other lawful invitees on the THA premises of any loss, bodily injury and damage to property due to any act of neglect or default of the successful bidder, its agents, employees and or servants. Tenderers shall be engaged as independent contractors and hence are wholly liable for any bodily injury or damage to plant and equipment.

# **17. CONFLICT OF INTEREST**

The OCS will ensure there is no Conflict of Interest in this tender. As such, any direct family relationship involving Tenderers and Members of the Division's Management and Staff must be fully disclosed. A member and/or officer of the Division or the relative of any such person shall not tender for the supply of items and or services stated herein. For the purposes of this tender the term "relative" means the father, mother, brother, sister, son, daughter or spouse of a person and includes the spouse of a son or a daughter of such person.

Failure to disclose may result in the disqualification of your tender submission.

# **18. RIGHTS OF THE OFFICE OF THE CHIEF SECRETARY**

In addition to the rights expressly hereinbefore referred to, the following additional rights accrue:-

- (a) The OCS reserves the right to reject any or all bids without limiting the generality of the foregoing, a Bid will be summarily rejected if it is conditional, if it is incomplete, obscure, or irregular, if it has erasures or corrections in the Cost Schedule, or if it has unit rates that are obviously unbalanced.
- (b) The OCS reserves the right to reject a Bid, which does not provide satisfactory evidence that the proponent has the technical, physical and financial resources to complete the work within a specified contract period.
- (c) The OCS reserves the right to accept or reject any bid and to annul the bidding process and reject all bids, at any time prior to Award of Contract, without thereby incurring any liability to the affected. Further, the Division does not have any obligation to inform the affected proponent or proponents of the grounds for the action.
- (d) The OCS may declare the bidding void when none of the bids meet the intent of the specifications or when it is evident that there has been a lack of competition and or that

there has been collusion. In addition, all bids may be rejected if they are substantially higher than the official budget approved by the Division.

- (e) The OCS does not bind itself to accept the lowest or any offer or to reimburse proponents for any expenses incurred in bidding.
- (f) The OCS reserves the right to cancel this tender at any time and has no obligation to provide any reasons for such cancellation.

# **SCOPE OF WORKS**

### THE SUPPLY, INSTALLATION AND MAINTENANCE OF WATER PUMPS AT BUCCOO INTEGRATED FACILITY

#### a) THE SUPPLY AND INSTALLATION OF ONE (1) WATER PUPMP

The successful contractor shall supply and install one (1) single stage impellar centrifugal Fire Pump that meets or exceeds the following specifications:

Voltage: 230/460 Volts

Phase: 3

Frequency: 60H

**Speed:** 3600 RPM

### b) THE MAINTENANCE OF FOUR (4) WATER PUMPS

The successful contractor shall provide monthly maintenance services for the following four (4) pumps located at the Buccoo Integrated Facility for a period of one (1) year:

General performance criteria shall include but not be limited to providing the following:

#### Routine Maintenance to Centrifugal water pumps which includes but is not limited to:

- 1. Checking and servicing the pump bearings and shaft
- 2. Checking bearing oil for water and discoloration
- 3. Checking pump for overheating and irregularities
- 4. Inspecting bearings and oil rings through filling ports and wiping bearing covers clean
- 5. Checking for oil leaks at the gaskets
- 6. Determining if mechanical seal conditions are normal

- 7. Checking the operability of heat tracing
- 8. Checking for leaks at pressure casing and gaskets. Determining if steam traps are operating properly- no continuous blow & water in casing or drain
- 9. Applying oil and/or gear to the bearing reservoirs, if required
- 10. Cleaning oiler bulbs and level windows as required
- 11. Changing oil in hydraulic governors
- 12. Checking for proper oil level and leaks at hydraulic governor. Checking for oil leaks at lines, fitting and power piston
- 13. Replacing guards, repairing if required.
- 14. Applying a light coat of rust preventative product to exposed machined surfaces to prevent rust and corrosion
- 15. Cleaning and oiling governor linkages and valve stems
- 16. Using a dial indicator to check the coupling alignment with the equipment coupled. Using special coupling indicator clamps where possible. Ensuring that thermal growth allowance is correct.
- 17. Using an indicator to check axial float of the pump & the driver shaft in similar manner
- Removing mechanical the governor cover & inspect flyball seat, spring, bearing & plunger for wear
- 19. Uncoupl from pump & overspeed turbine. Ensure that trip valve will stop turbine with steam supply valve (throttle valve) fully open. Compare tripping speed with previous records. Adjust trip mechanism & repeat procedure. Follow manufacturer s instructions when making adjustments
- 20. Where the process will allow it, test run the turbine coupled to the pump. When not possible, run the turbine uncoupled. With a tachometer verify proper governor operation & control. Determine if hand (booster) valves are completely closed when required to carry load.
- 21. Call outs to rectify emergency issues particularly during large scale events which can occur on weekends, public holidays and nights.

#### Routine Maintenance to Fire Pumps which includes but is not limited to:

- 1. Check pump suction, discharge and bypass valves to ensure they are open and piping is free of leaks
- 2. Test the automatic start by opening test line to reduce system pressure
- 3. Check that controller is in automatic start mode
- 4. Verify receipt of remote-monitoring alarms during automatic start test
- 5. Verify that pressure relief valves operate properly.
- 6. Check water flow out of the shaft seal packing in the stuffing box. Also check the pump casing and bearings for overheating and signs of excess vibration
- 7. Call outs to rectify emergency issues particularly during large scale events which can occur on weekends, public holidays and nights.

The contractor will also be responsible for undertaking the following:

#### **Repairs to Fire Pump Located at the Administrative Building:**

- Evaluation of pump
- Complete servicing
- Contactor overload installation for control panel


