An electronic copy of the complete set of RFP documents will be provided via email from <u>dspurd@tha.gov.tt</u> The request should contain the following information:
 - i. the Contractor's business name, address, telephone number and email; and
 - ii. the name, designation, email address and direct contact number of the contractor's designated representative for the purpose of the RFP.
- 4. Contractors' representatives are encouraged to attend a virtual pre-submission meeting, on the date and time indicated in the table above. An electronic meeting invitation will be issued to all Contractors requesting the RFP documents.
- 5. The contract will be awarded in accordance with the pre-defined evaluation methodology outlined in the RFP documents. The services to be provided will be governed by the terms and conditions outlined in the draft contract include in the RFP Document.
- 6. Bids must be completed and submitted in accordance with the instructions outlined in the RFP documents, and must be accompanied by the following:
 - i. Copy of Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue, valid as at the date of submission of Proposals.
